



## **Decision of the Governing Board on the approval of the revised organisational structure of the Programme Office**

### **THE GOVERNING BOARD OF THE CLEAN SKY 2 JOINT UNDERTAKING**

Having regard to Council Regulation No 558/2014 of 6 May 2014 establishing the Clean Sky 2 Joint Undertaking<sup>1</sup>;

Having regard to the Statutes of the Clean Sky 2 Joint Undertaking annexed to Council Regulation No 558/2014 of 6 May 2014 ('the Statutes'), and in particular Articles 8.2 (g), 10.4 (l) and 10.5;

Having regard to the organisational structure of the Clean Sky 2 Joint Undertaking approved by the Governing Board of 3 of July 2014<sup>2</sup> and revised by the Governing Board Decision of 6 July 2017<sup>3</sup>;

Having regard to the applicable staff establishment plan of the Clean Sky 2 Joint Undertaking adopted by the Governing Board by Decision of 9 April 2019<sup>4</sup>;

#### **WHEREAS:**

- 1) The Governing Board is responsible for approving the organisational structure of the Programme Office upon a recommendation of the Executive Director;
- 2) The Executive Director recommended to the Governing Board, in its meeting of 9 April 2019, a revision of the organisational structure of the Programme Office in order to achieve a more efficient organisation, direction and supervision of the staff and operations.
- 3) The revised organisational structure constitutes an internal re-organisation of current staff members among the existing units while ensuring more efficient reporting lines for audit, legal and communication and does not affect the Staff Establishment Plan in force.

#### **HAS DECIDED:**

##### **Article 1**

The revised organisational structure of the Programme Office of the Clean Sky 2 Joint Undertaking annexed to the present decision is hereby approved.

##### **Article 2**

This decision shall enter into force on the day following that of its adoption.

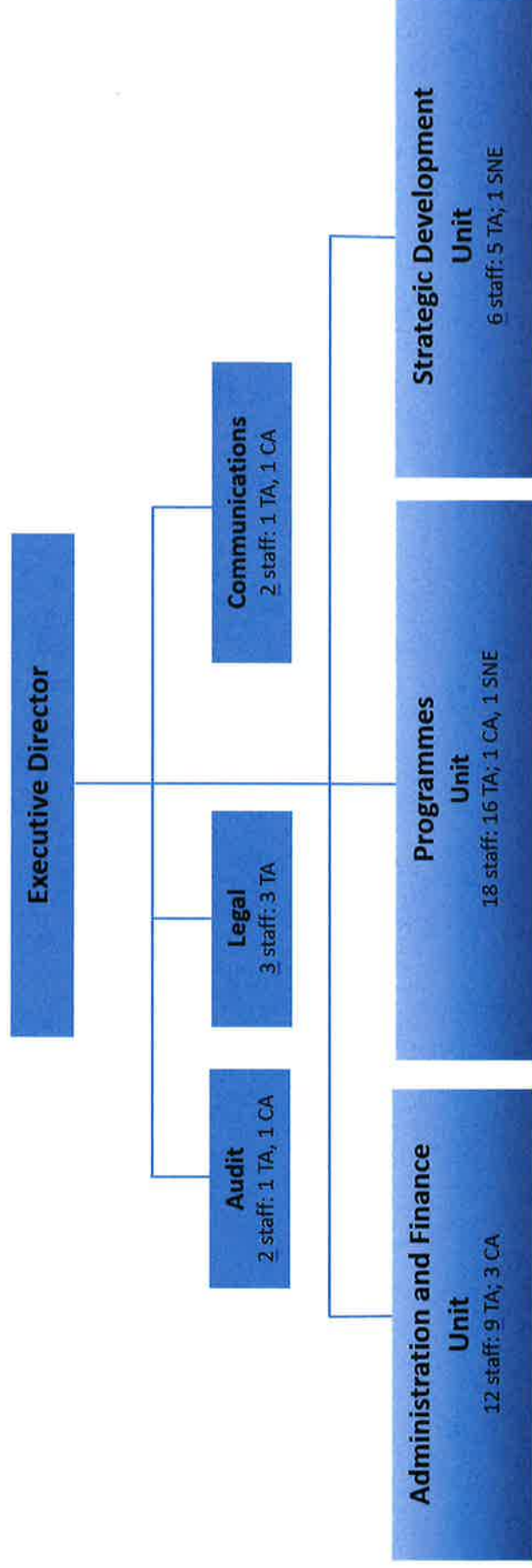
